Smart industry and the pathways to HRM 4.0: implications for SCM

Abstract

Purpose – The purpose of this paper is to address the potential impacts of Industry 4.0 on human resource management (HRM) – with a particular focus on employment, job profile and qualification and skill requirements in the workforce – which can have implications for supply chain management (SCM). Consequently, exploratory relationships among Industry 4.0, HRM and SCM are presented based on a systematic review.

Design/methodology/approach – To explore Industry 4.0 literature and its impact on employment, the authors used a systematic literature review to identify, classify and analyze current knowledge, flagging trends and proposing recommendations for future research in this area. Using the Web of Science database, the authors utilized co-citation software to visualize the networks which emerged from recurrent terms and which were then used to develop the categories of analysis.

Findings – The authors can affirm that the literature in this field is in a transition process, from the early studies of German academics to the current development of new impacts worldwide. Industry 4.0 is the central theme of the literature analyzed and is accomplished through the development of employment, qualifications, skills and learning frameworks. The results reveal that most papers are conceptual, with quantitative studies still lacking. Developed countries have a leading role in terms of research production, while Latin America and Asia are far behind. Clustering reveals four dominant themes (educational changes, employment scenario, work infrastructure resources and work meaning and proposal). The first refers to labor changes around working conditions, the work environment and new skills which are required. The second main theme concerns the potentially unstable shift in the labor market has toward a high-level context. The third is about the technical interface of humans and machines, and finally, the fourth understands the German industry as a starting point for global industrial improvements and work proposal changes. Furthermore, socio-technical systems cover the implications of HRM for SCM in three different dimensions: qualification and education (human competences), collaboration and integration of SCM (organizational competences) and data and information management (technical competences).

Research limitations/implications – An original research agenda for further development of the topic. Additionally, the implications of the findings for SCM practitioners are presented.

Practical implications – SCM managers can benefit from the results of this paper by developing adjusted polices for organizational and human aspects. Specially about training programs to improve technology skills and education programs for cyber-human new plataforms.

Originality/value — So far, Industry 4.0, HRM-related topics and implications for SCM have generally been considered separately. This paper elucidates the few important studies on the impacts of Industry 4.0 on human-related topics, such as the labor market, building a research framework using the main contributions highlighted in the literature. An original research agenda is presented, as well as potential implications for SCM.

1. Introduction

Currently, because of the rapid development of digitalization and robotics, we are facing the next industrial revolution, known as "Industry 4.0". Disruptive changes are taking place in the global manufacturing system (Strandhagen et al., 2017) through the use of smart technologies that enable new and more efficient processes, products and services (Lee et al., 2015; Zhong et al., 2017). Digitalization develops in various sectors at different speeds, depending on the complexity of business models. This change represents risks, challenges and opportunities to industry stakeholders and communities (Roblek et al., 2016; Strandhagen et al., 2017; Hirsch-Kreinsen, 2016).

Such changes will not collapse the entire system (Rajnai and Kocsis, 2017); rather, society will react more slowly, remaining at least close to a steady state situation. One of the main reasons that abrupt transitioning is not possible is the integration between Industry 4.0 and HRM-related topics, such as a lack of skilled staff to promote radical changes across entire supply chains, as HRM issues can affect supply chains considerably (Gowen III and Tallon, 2003). Keynes (2010) affirmed that technical efficiency increases faster than we can deal with the problem of labor absorption. These employment changes are multifaceted and complex, making it difficult to attribute specific causal effects (Evangelista et al., 2014) toward reaching conclusions on positive and negative perspectives.

Job numbers will generate redundancy effects across the global economy (Roblek *et al.*, 2016). While estimates show that 47 per cent of American (OECD, 2015) and 30 per cent of British (Elliot, 2017) jobs are under high risk in the next 20 years, and in China over 60,000 workers were rendered jobless in 2016 when Foxconn decided to replace them with robots (Wakefield, 2016), Berger (2016) asserts a 50 per cent level of job absorption in the Western European economy in the same time range.

Relocation of activities, leveraging new business models, reinvestment in new industrial products and equipment and new services also change the employment scenario (Berger, 2016). Old work activities are disappearing and being replaced, and entirely new ones are being created. The most in-demand occupations today did not exist 10 or even five years ago; 65 per cent of children entering primary school today will ultimately end up working in entirely new jobs that do not yet exist (WEF, 2016).

There will be a positive variation in wage and job impacts on different economies (Rajnai and Kocsis, 2017; WEF, 2016) depending on the competitive level of technological gaps between countries. Kergroach (2017) points to the trend of minimization of precarity in work conditions in developing countries. Employees in such countries tend to lose more jobs and comparative advantages, as the actual logic of low-cost labor is contradictory to rising labor costs and the decline of jobs due to technological efficiency, leading to companies restoring operations back to their home countries (Calitz et al., 2017).

Labor constraints and amount of jobs are only the tip of the iceberg; in a broader view, the role of the human factor will be indispensable to smart industry and SCM. This consideration does not only influence production itself, but also the

occupational dimension, job dynamics, working conditions, educational system, skills demand and national policies (Benešová and Tupa, 2017; Rajnai and Kocsis, 2017). Specifically, qualifications and skills will be critical because companies will have to adapt to constant technological shifts (Harkins, 2008), turning knowledge management (Nonaka et al., 1996) and IT knowledge (Pfeiffer, 2016) into the key to success for a highly innovative factory (Gehrke et al., 2015), making digitalization of production possible (Rajnai and Kocsis, 2017).

The primary challenge now is moving beyond new technologies toward complete automation, and the resulting competitive struggle between humans and machines for knowledge-intensive jobs in the field of computing, self-learning, algorithms and data analysis. The question that arises concerns the best possible cooperation between humans and machines (Benešová and Tupa, 2017) within SCM.

Horizontally, the challenge is focused across SCM, and vertically, throughout the levels of an organization (Hecklau et al., 2016). Industry, as a whole, should be focusing on human resources management (HRM) (Legge, 1995; Huselid, 1995), and moreover, on people management (Thompson, 2013), suppressing traditional approaches to recruitment, selection, staffing in favor of hiring a workforce to train, developing employees and learning environments (Becker, 2013). Industry 4.0 transposes the traditional HRM onto a new model, one which is able to deal with the "not so new" but still challenging Learning 4.0 and Education 4.0 (Harkins, 2008).

HRM 4.0, as it is called, materializes the industry strategy for filling in the blanks around their dynamic capabilities (Teece et al., 1997; Eisenhardt and Martin, 2000) to adapt and survive in the 4.0 market, combining real and virtual global information and IT management knowledge (Hecklau et al., 2016). All of these terms are used to describe the managerial and market revolution that the reality of Industry 4.0 is bringing. The use of these terms helps to familiarize scholars and practitioners with the upcoming changes that Industry 4.0 is bringing and which are currently being discussed across different domains of knowledge.

These changes are coming rapidly, and virtual-human interface solutions are not always obvious, reaching organizationally, socially and culturally obscured paths. Qualifications, skills and adequate learning frameworks are relevant issues to support the future agenda for organizations and supply chains. The impacts of HRM 4.0 on supply chain management (SCM) are based on the natural and intrinsic relationships between human-related issues and the adoption of SCM practices and trends.

Consequently, transformations in HRM can impact SCM, as previously asserted by Gowen III and Tallon (2003). Moreover, the integration of HRM and SCM can still be considered an important area for further understanding SCM (Lengnick-Hall *et al.*, 2013). In a scenario in which Industry 4.0-related HRM occurs, SCM practices can achieve even higher levels of excellence. This perspective is supported by Ellinger and Ellinger (2014), authors who affirm that HRM can contribute to the success of SCM practices. Thus, any improvement in HRM across a supply chain can signify a move toward higher levels of SCM practices.

Overall, a relatively small number of important works (Gowen III and Tallon, 2003; Lengnick-Hall *et al.*, 2013; Ellinger and Ellinger, 2014) have contributed to the literature on the integration of HRM and SCM. Further, it is possible to suggest that the available literature on the integration of HRM 4.0 and SCM – as proposed here – is even more scarce than in the traditional HRM–SCM gap. This work, thus, proposes one of the first explorations on the relationships among Industry 4.0, HRM (with a focus on employment and workforce trends) and SCM. We hope that this discussion will pave the way toward a proper future research agenda, which will shed light on real-world problems facing SCM in the context of HRM 4.0

In this sense, the purpose of this paper is to address potential impacts of Industry 4.0 on HRM – with a particular focus on employment, job profile and requirements for qualifications and skills of the workforce – which can have implications for SCM. The main contributions of this work are as follows:

- We present original results concerning a systematic literature review, through identification, classification and analysis of current knowledge concerning the effects of Industry 4.0 on HRM-related topics, such as employment and job profile, which can affect SCM.
- We develop an original research agenda for progressing the still-scarce discussion on the potential implications of Industry 4.0-HRM on supply chain management.
- We conclude this work by presenting implications for the supply chain community.

2. Theoretical background

Technical and economic changes arise from new combinations of knowledge, know-how (Lundvall and Johnson, 1994) that allows new ways of producing goods and services to infer a rescue from Schumpeter's (1985) "exchange economy".

Besides industry developments toward the digitalization of manufacture, the technological push of Industry 4.0 forces organizations and supply chains into adaptive behavior, driving them into new management processes which are promoted by evolutions in learning. Industry 4.0 will affect the way HRM and human-related trends are considered by companies.

In this work, human resources-related topics are understood to include the ways in which firms adapt recruitment, training, performance appraisal and rewards of employees in light of external trends, such as technological changes and competitive forces (Jackson et al., 2014). From a broader perspective, HRM relates to methods for keeping the workforce updated, skilled and aligned with stakeholders' expectations (Jackson et al., 2014). Regarding SCM, it is defined as "the integration of key business processes from end user through original suppliers, that provide products, services, and information that add value for customers and others stakeholders" (Lambert et al., 1998, p.2).

According to Sivathanu and Pillai (2018), organizations will need to align their HRM strategies and practices with Industry 4.0, including topics such as workforce employment and skills development. In this sense, certain digital skills might be needed in this Industry 4.0 future, such as problem-solving, non-routine tasks and creation of digital outputs (Djumalieva and Sleeman, 2018). This is because some technologies, such

as the Internet-of-Things, Big Data and artificial intelligence, will automate most of the HR processes, resulting in efficient and leaner HR teams. Industry 4.0 will impact human-related topics across supply chains, such as training, development, employment, skills development, etc.

Organizations and supply chains that are in the process of implementing an innovation process or that display the organizational antecedents of innovation (Damanpour, 1991; Wolfe, 1994; Nelson and Winter, 2005) are more prepared for the required learning on human–machine interface management. An increased incorporation of technology components into HRM-related topics, with attendant implications for SCM, will need to be better understood.

For this purpose, certain exploratory theoretical frameworks have been developed. Organizational competencies for Industry 4.0 have been designed, such as technical (domain), methodological, social and personal (Hecklau *et al.*, 2016). Kinkel *et al.* (2017) address the ability to build networks or to solve complex problems for innovativeness in the industry, which these competencies can provide when dynamically applied in HRM.

The socio-technical systems (STS) (Trist, 1981; Geels, 2004) perspective can be a successful way to understand this complex change. Social and technological aspects no longer innovate separately. This perspective presumes that it is necessary to develop novel approaches for work-integrated qualifications and instruments of learning organizational methods, especially about digitalization (Ropohl, 2009; Schuh et al., 2015). Furthermore, collaborative types of learning and learning environments are critical to organizations for operationalizing knowledge and competencies, such as the use of virtual learning environments (VLEs) (Anjarichert et al., 2016), augmented reality (Azuma, 1997) and collaborative environments between Cobots (service robots) and humans (Calitz et al., 2017).

Dregger *et al.* (2016) and Hirsch-Kreinsen (2016) designed one of the proposed models for Industry 4.0 and STS change. HRM becomes the center of the human–technology interface relationship (Figure 1).

This ongoing change can also disrupt the status quo of educational systems. Industry 4.0 will strongly impact higher education (Baygin *et al.*, 2016). A trend of new education business models entailing high costs forces the privatization of some institutions and establishment of corporate universities

and professional schools by big companies (Störmer et al., 2014).

Industry 4.0 will change society and firms, humans and supply chains, launching a number of trends and challenges across supply chains. As HRM-related issues can have significant effects on operations, quality and excellence of supply chains (Gowen III and Tallon, 2003; Lengnick-Hall et al., 2013; Ellinger and Ellinger, 2014), it is possible to understand that HRM 4.0 will change the way supply chains operate (Sivathanu and Pillai, 2018). HRM-related issues can be key either for the success or the failure of organizational initiatives (Jackson et al., 2014), such as the adoption of Industry 4.0 across supply chains.

3. Method

A literature review in the field of management or organizational studies is the first step of scientific research and is presented as a brief introduction to an empirical study or as an extensive detailed account of a body of literature. Over recent years, new formal approaches and systematic methods have been created to locate, select, appraise, summarize and report evidence (Denyer and Tranfield, 2009; Tranfield *et al.*, 2003).

Research on emerging issues provides important support in portraying efforts to indicate the challenges faced by future studies of systematic literature reviews (Liboni-Amui *et al.*, 2017; Mariano *et al.*, 2015; Huisingh, 2012). Systematic literature reviews enable the analysis of the past to prepare for the future, uncovering the body of knowledge by identifying research that is relevant to a specific subject (Kitchenham, 2004; Webster and Watson, 2002).

For Tranfield et al. (2003, p. 220):

The aim of the systematic review is to provide collective insights through theoretical synthesis into fields and sub-fields. For academics, the reviewing process increases methodological rigor. For practitioners/managers, systematic review helps develop a reliable knowledge base by accumulating knowledge from a range of studies.

Systematic reviews differ from traditional narrative reviews because of their replicable and transparent process. To reduce human error and bias, systematic reviews use data-extraction methods, which require documentation of all steps. Data extraction must contain general information, such as title, author, publication details, as well as the research specific information, such as method and notes on emerging themes (Transfield *et al.*, 2003).

Jabbour (2013) and Lages Junior and Godinho Filho (2010) propose that a systematic literature review should involve certain steps, such as:

- survey the available articles published on the subject;
- develop and validate (i.e. in a research group) a classification code system to provide structure to the existing knowledge on the subject;
- identify and analyze the main results of the articles based on the coding system;
- · explore and describe the gaps in the literature; and
- indicate the opportunities and challenges for future studies.

Therefore, the objective of this paper is to systematize the available knowledge on the impacts of Industry 4.0 on the labor market by:

- identifying articles on Industry 4.0 and labor;
- classifying and codifying characteristics of these articles;
- · discussing the results of the literature review; and
- providing a framework for addressing the gaps in the current knowledge, contributing to a future research agenda.

This research, based on a systematic literature review, used an extraction process involving two rounds of analysis. After the first step – individual analysis conducted by different researchers – the findings were compared and reconciled when necessary, as suggested by Tranfield *et al.* (2003).

The database used was the ISI Web of Knowledge (Web of Science) because of its importance as an online subscription-based scientific citation indexing service. The systematic search used a group of key words to identify articles related to Industry 4.0 and employment. The terms used were: "Industry 4.0" and "labor"; "Industry 4.0" and "employee"; "Industry 4.0" and "employment"; "Industry 4.0" and "workforce". All of the resulting studies from the search were incorporated, without the use of refinement mechanisms by area (management, engineering, education, among others) or type of research (proceedings, articles).

In addition, we expanded the search to include articles in two other languages – German and Spanish. German was included because Germany is the cradle of Industry 4.0, and Spanish because it is the most widely spoken language in the world. This additional searching provided one relevant article in German.

After collecting the relevant articles, an analysis was conducted to verify that all of them discussed Industry 4.0 from a labor market perspective. Therefore, all the articles were analyzed to better understand whether their nature genuinely concerned labor or employees in Industry 4.0. Some articles were excluded because they did not discuss these topics. Those that did not integrate both themes and those which were unavailable for download were removed from the study. The excluded papers represented less than 10 per cent of the total number of papers on the subject. From the 62 studies identified, six papers were excluded because they were unavailable for download and four were excluded because they were duplicates of existing results. Table I shows the results of the searches and the number of remaining papers considered for review.

Systematic reviews use a set of explicit selection criteria to assess the relevance of each study identified (Denyer and Tranfield, 2009). Before a careful codification of the papers, they were analyzed using the VOSviewer software (version 1.6.7), a tool for constructing and visualizing bibliometric networks (Figure 2). These networks, enabled by the text mining functionality, were used to construct and visualize co-occurrence networks of the important terms that appeared in the literature, representing a way of pointing out the main topics studied and the opportunities for future research.

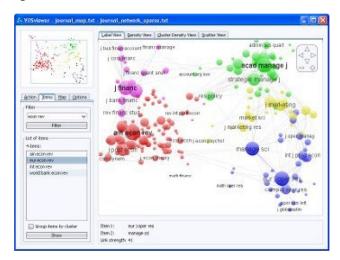


Figure 3 Preliminarily network for categories development

The terms from abstracts that appeared in the networks as the most recurrent were used initially for the development of categories of analysis, as seen in the network below (Figure 3). Together with these categories, other general and specific information, such as method and research technique, as well as the dimensions adapted from Jabbour and Santos (2008), were used as categories to analyze the existing articles.

The classification framework was developed using the number and letters codes to classify the articles. The classification dimensions were (Table II):

- 1 Emphasis (1), coded on a scale A-B;
- 2 Aspects (2), coded A-C;
- 3 Research method (3), coded on a scale A-B;
- 4 Research design or technique (4), coded on a scale A-F;
- 5 The approach, coded on a scale A-B;
- 6 Focus, coded on a scale A-C;
- 7 Origin, coded on a scale from A-E;
- 8 Dimensions of HRM, coded A-H;
- 9 Changing and effects of Industry 4.0 on HRM, coded on a scale from A-C; and
- 10 SCM, coded on a scale from A-L.

In summary, the methodological research scheme can be seen below (Figure 4).

Many systematic reviews use two or more independent reviewers to extract data from studies (Denyer and Tranfield,

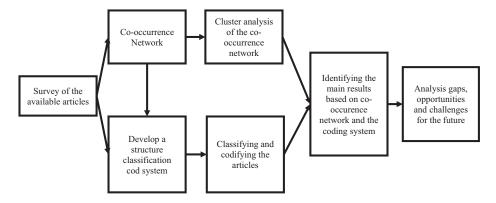

2009). After creating the above codes and categories, a methodological step to strengthen the systematic research and validate the codes was implemented. The papers selected to be analyzed and codified were sent to six researchers from our

research group (CISS – Center on Innovation, Systems and Sustainability). Their objective was to read the papers, validate our categorization method and codify the articles. The code for SCM arose from this step, with all other codes and categories being validated.

4. Results and discussion

The research results are divided into three main topics. First, we present the coding systems which emerged. Second, the co-occurrence networks are analyzed. Finally, we discuss the results aligning the actual knowledge corpus and a research agenda for future studies.

4.1 Coding system results

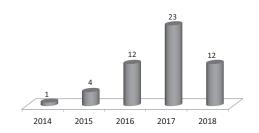
After analyzing the papers, 52 articles were selected to be classified. These were mostly published between 2014 and 2018, with 12 publications already in 2018 (Figure 5). In this context, the subject can be seen as recent, and so far largely unexplored in the literature, but it has been rising during the last few years.

Descriptions of papers selected for this analysis are available in Appendix 1, while Appendix 2 shows the codifications for the systematic review performed in this research. Table III describes a summary of each of the 52 papers.

4.1.1. Emphasis of the discussion

This category verifies whether the paper treats Industry 4.0 as a central theme or uses it as a peripheral issue for other analysis. It can be seen from Figure 5 that the discussions of articles

focus primarily on aspects of Industry 4.0 as a central item. This analysis is also corroborated from the data in Figure 6, which presents a network of keywords of the categorized studies. It is noted that the core keyword is Industry 4.0, but there are simultaneously keywords in the areas of computer science, engineering and HRM, reaffirming the multidisciplinary emphasis of Industry 4.0.

4.1.2 Aspects covered

This category considers the sorting of the papers into technical, human or managerial aspects. Figure 7 shows that, in 44 of the 52 articles analyzed (more than 80 per cent), human aspects are discussed. It is interesting to note that, in 27 of the 52 articles (more than 50 per cent), there are discussions about more than one aspect, which corroborates a multifaceted view of the theme and reinforces the STS as a valid framework of analysis.

4.1.3 Method

This category aims to check the methods used in the analyzed articles: qualitative or quantitative (Figure 8). Almost 90 per cent of the papers developed qualitative research. This result may represent research opportunities for quantitative methods, to test given propositions and validate suggested hypotheses.

4.1.4 Research techniques

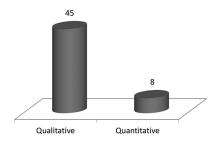


Figure 9 Distribution of Category 4 – research technique

This category aims to verify the research techniques used in the analyzed papers: a case study, interviews, survey, focus group, reviews and simulation/programming/others (Figure 9). More than 59 per cent of the articles used literature review as the main method. The case study was also a highlight: almost 16 per cent of the papers developed research through this technique. It is relevant to emphasize that there were few (or no) studies using survey, focus group, simulation, programming or other different techniques.

4.1.5 Approach

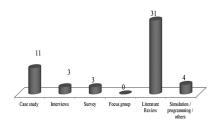
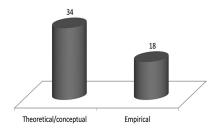


Figure 10 Distribution for Category 5 – approach

The majority of the papers brought a theoretical/conceptual approach (65 per cent) (Figure 10). Empirical research has growth potential, as Industry 4.0 is an emergent and relevant theme. Researchers may be able to develop creative insights through empirical research to face challenging problems.

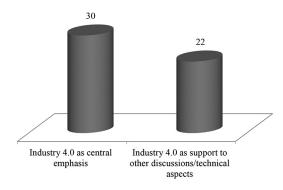

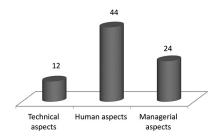

Figure 8 Distribution of Category 3 – method

4.1.6 Focus

The objective in this category was to find out the principal geographic region of the paper: emerging economies, developed economies or not applicable. More than 40 per cent of the papers discuss the key theme with a focus on developed economies. Only 12 per cent focus on emerging economies (the others were not applicable – no specific focus) (Figure 11). These results show an avenue of research opportunity to explore how the "Industry 4.0" phenomenon will affect emerging economies and what are the possible upcoming changes and impacts.

4.1.7 Origin

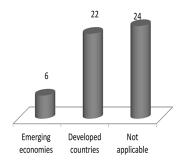
The majority of the database came from Europe – more than 90 per cent of the sample (Figure 12). Not a single paper came from Latin America, and only a few came from the other regions (North and Central America, Asia and Oceania and Africa). These results show that Latin America (as well as North and Central America, Asia and Oceania and Africa) can make great progress, for instance, by developing studies as a research alliance platform.

4.1.8 Dimensions of HRM

The most important dimension of HRM (Figure 13) in the sample of this systematic review was "Training and

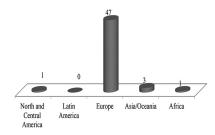

Figure 11 Distribution of Category 6 – Focus



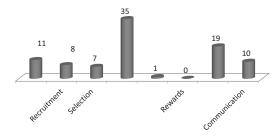

development" (almost 68 per cent), followed by "Leadership and teamwork" (almost 37 per cent) and "Communication" (almost 20 per cent) (Figure 12). Rajnai and Kocsis (2017) suggest that companies should adapt their HR activities to the changing labor market conditions; Reuter et al. (2017), using a learning factory setting, analyze the effects on workplaces and labor conditions for employees, showing that this approach

enables more engagement in technology-based processes. Meanwhile, Dregger *et al.* (2016) affirm that practitioners and researchers should explore the organizational conditions needed to bring a human-oriented "Industry 4.0" project.

4.1.9 Changes and effects of Industry 4.0 on HRM

The majority of the analyzed papers highlight changes in the way of working. Almost 64 per cent of the papers discuss this issue (Figure 14). Bobkov and Kvachev (2017) criticize the future changes as a manifestation of the new global order produced by the multitude of local disorders. On the other hand, Trompisch (2017) argues that the use of Industry 4.0 technologies in enterprises will not lead to full automation, suggesting a future scenario of cooperation.

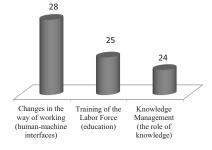
4.1.10 Supply chain management

Almost 29 per cent of the papers highlight "People and Leadership" as a dimension of SCM. This is a curious result, as this subject is directly connected within HRM. Thus, this represents that the integration between both themes (HRM and SCM) is being discussed in the literature (Figure 15).

4.2 Network analysis

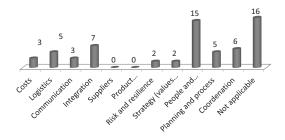
To understand how the studied issues are related, two cooccurrence networks were developed. The first network was constructed considering all the keywords with at least two instances. We identified 22 such keywords (Figure 16).

Figure 14 Distribution for the Category 9 - Changing and effects of Industry 4.0 on HRM



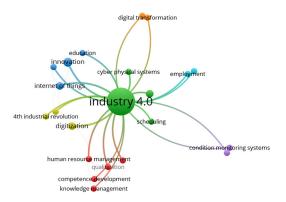

The core keyword is Industry 4.0, but it is possible to identify ramifications linked to HRM, engineering and computer science. It should be emphasized that keyword categorization may be useful to other researchers through highlighting emerging topics and how they relate to each other. In this sense, a complete list of keywords per cluster is shown in Table IV.

In turn, a second co-occurrence network (Figure 17) was elaborated based on the abstracts of the analyzed articles. The term "employment" has centrality in this network of words and connects the four clusters generated.

In this context, changes in employability issues are central to the discussion, although they have a distinct focus depending on the cluster to which they belong. The terms that appear in each cluster are pointed out in Table V.

Clusters 1 (educational changes) and 2 (employment scenario) have as their central aspect the Fourth Industrial Revolution, the changes needed from the educational point of view and its consequences for the future. In this context, developing new technologies might generate new business models that consequently will change job patterns and create new employment opportunities (Rajnai and Kocsis, 2017).

The proposed state of Industry 4.0 will affect not only manual, heavy and repetitive work, but also intellectual and cognitive work (Kergroach, 2017):

In industry, this concerns not only the activities on the shop floor, but also the indirect areas, from planning and control systems to product development, and the demands on leadership and management will also change significantly (Dregger et al., 2016).

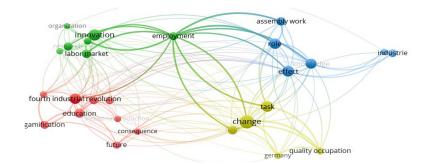
Table VI summarizes the main expected impacts on HRM through the digitization process.

It is expected that the digitization process will naturally generate the creation of new products, services, processes and business models. The papers suggest that work will change permanently as the application of digital technologies advances across the various sectors of the economy (Dregger *et al.*, 2016). The changes in the methods of production and introduction of new technologies should lead to gains in efficiency and industrial productivity (Kergroach, 2017; Rajnai and Kocsis, 2017).

On the other hand, this process will lead to the loss of jobs and replacement of labor by machinery. "Where there were many factory workers in the previous era, there will be few highly-qualified engineers and programmers in the future" (Bobkov and Kvachev, 2017). Also, digitization can lead to new waves of job shifts in emerging countries with lower labor costs and the growth of precarious work, which is explained as a consequence of the division of labor markets and the changing nature of labor (Kergroach, 2017; Rajnai and Kocsis, 2017; Bobkov and Kvachev, 2017).

It is noted in the literature that the main limitation for the advancement of Industry 4.0 is the lack of skilled labor. This limitation acts as a constraint on the current development of Industry 4.0, as well as restrictions in the medium and long term, given the professional profile formed in educational institutions (Baygin *et al.*, 2016; Motyl *et al.*, 2017; Benešová and Tupa, 2017).

Thus, the academic curriculum must be redesigned, taking into account the principles of Industry 4.0 (Baygin *et al.*, 2016). The development of soft skills should be encouraged as they will be necessary for the advancement of the industry, and

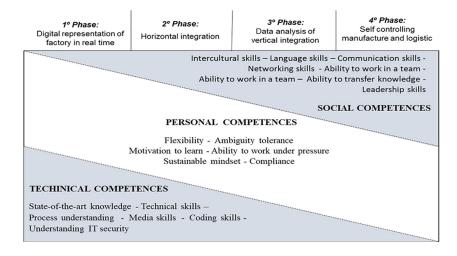
because they are difficult to automate, will concentrate job opportunities for humans rather than machines (Kergroach, 2017). "University needs to create broader and better-structured knowledge of the basic concepts related to this new industrial revolution" (Motyl et al., 2017).

In this sense, it will be necessary to have new jobs with high skill requirements (Hedvicakova and Svobodova, 2017), and nowadays, there is a lack of specialists, which could be covered by the implementation of a new curriculum for students (Kharchenko *et al.*, 2017). It is expected that "the number of workspaces with a high level of complexity will increase, resulting in the need for a high level of staff education" (Hecklau *et al.*, 2016). The papers have listed human tasks in existing and future cyber-physical production systems and estimate the evolutionary behavior of these tasks (Becker and Stern, 2016). Thus, based on the works of Benešová and Tupa (2017) and Hecklau *et al.* (2016), it is possible to identify key competencies to be encouraged throughout the deployment phases of Industry 4.0 (Figure 18).

Figure 18 presents, at the top, the four-phase implementation sequences of Industry 4.0 (Benešová and Tupa, 2017). Throughout these phases, HRM should encourage technical, personal and social skills (Hecklau et al., 2016). However, as the stages progress, the importance of social skills such as intercultural skills and leadership increases.

The first phase consists of the introduction of ERP and ERP II information systems. This phase will initially require engineers with a technical background in business process mapping. Increasing scanned data will also require IT professionals (Benešová and Tupa, 2017). In this context, technical skills on process understanding, data security and IT will be key success factors (Hecklau et al., 2016).

The importance of technical skills persists in the second phase, where horizontal integration and implementation of automatic machines are expected. Thus, the technical knowledge of process engineers will be critical at this stage. In addition, personal skills such as tolerance and motivation to learn should be encouraged, as phase 2 begins to generate significant changes in methods of working (Benešová and Tupa, 2017; Hecklau *et al.*, 2016).

The third phase involves data analysis and vertical integration:

And here we will find the biggest problem of Industry of 4.0. Education systems did not predict the rapid demand for data analysts, so the data analysis as a field of study is very small and underdeveloped at this time (Benešová and Tupa, 2017).

One of the alternatives in this context is the development of learning factories, in which it is possible to adequately train this new work profile, getting acquainted with new technologies in business process mapping and data analytics (Prinz *et al.*, 2016).

As vertical integration occurs, one must be attentive to how to integrate employees in this context of changes in the social and technical system. This integration will be fundamental to increase the flexibility of the manufacturing system while taking advantage of the best technological solutions and human potential installed (Fantini *et al.*, 2016). For example, the challenges of this transition are how the labor market will be affected by the implementation of partnerships with collaborative robots (Calitz *et al.*, 2017) and artificial intelligence (Rajnai and Kocsis, 2017).

In the fourth phase, it is expected that the production systems will be almost autonomous. Operators, data analysts and quality control systems will be needed. The integration in this model will overcome the vertical structure, connecting factories in regions or even different countries. In this sense, logistics and transportation activities will be essential (Benešová and Tupa, 2017). To deal with hyperconnected systems, social skills such as intercultural skills, language skills, leadership and teamwork will be essential (Hecklau et al., 2016), as several technical processes at this stage can be performed by robots and artificial intelligence (Kergroach, 2017; Calitz et al., 2017).

Cluster 3 (work resources infrastructure) has a technical approach, focusing on the effects and role of knowledge in this context of changes in employment. Studies are focusing on the current and future implementation of collaborative robots and its impacts on the workforce and workspace (Calitz *et al.*, 2017). Furthermore, the general scenario of the latest technological trends of Industry 4.0 and their consequences on the structure of the labor market is also a significant highlight (Kergroach, 2017):

- Artificial intelligence (AI) can contribute to the development of new types of software and robots directing their learning and operation independently of human decisions, becoming autonomous agents.
- Robots with AI will significantly impact logistics and manufacturing processes, as they can ensure greater safety, speed, accuracy and productivity.
- The benefits of such emerging technologies will be gained through the adaptability of labor markets.
- Technological change is one of the main factors that can influence employment markets.

In the case of assembly plants, it may be hard to replace humans with robotics, and assembly work should not be tagged as simply routine work, as complex work environments depend on

human skills, and even more, on their experiential abilities. These aspects are the opposite of simple routine (Pfeiffer, 2016). Besides, how to evaluate learning cultures in the context of Industry 4.0 is also a relevant research question (Plumanns et al., 2015). There are also papers addressing how the Fourth Industrial Revolution will change the nature of labor, leading to inequality as a result. All this may lead to the expansion of precarious employment – the deconstruction of standard employment relations is based on four factors:

- 1 the dynamics of labor market divisions;
- the Fourth Industrial Revolution;
- 3 the changing nature of work; and
- 4 the intervention of neoliberal ideology (Bobkov and Kvachev, 2017).

At the same time, businesses and society do not have the option of not pursuing Industry 4.0 and collaboration-based practices (Calitz *et al.*, 2017).

Finally, Cluster 4 (work meaning and proposal) shows the importance of the change process in Industry 4.0. The starting point was German conferences and working papers, but the development of innovative behaviors (Lukes and Stephan, 2017) and culture of innovation (Patterson *et al.*, 2005; Reicher, 2011) ensure that the shift to digitalization is global. Changes in the socio-technical production system (changes in the technological system, the human operating system or in the organization system) will affect people in the workplace (Dombrowski and Wagner, 2014), and research regarding ergonomic work systems is gaining space. A significant finding by Dombrowski and Wagner (2014) is that there is less research on the relationship between Industry 4.0 technologies and how these technologies are going to impact mental issues.

Regarding HRM in the Industry 4.0 scenario, changes can be divided into two types (Dombrowski and Wagner, 2014):

- 1 Job profile change: from the execution of specific manufacturing tasks to interdisciplinary cooperationbased tasks; and
- 2 Competency change: from specific technical abilities to problem-solving and complexity abilities.

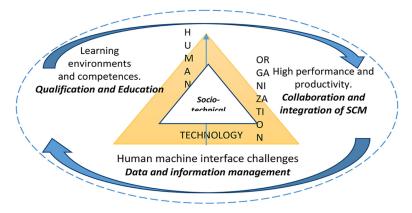
The evolutionary behavior of job profile and competency change in the context of Industry 4.0 (Dombrowski and Wagner, 2014) corroborates the conclusions of Benešová and Tupa (2017) and Hecklau *et al.* (2016) and is related to the ideas presented in Figure 18.

The balance between job losses in the medium-term economy and the promise of highly qualified occupations is more feasible in Germany, as this country presents dedicated reports such as Rajnai and Kocsis (2017). Differences will be focused on the level of automation of each nation, leading developed countries more naturally adapted to perform changes in organizational and social support systems. The trend shows that this balance is a part of the overall industry change, which is approaching all countries in the long-range perspective. Also, as pointed out by Rajnai and Kocsis (2017), all stakeholders must be engaged with the challenges, risks and opportunities of digital transformation, at all levels: individuals, companies, countries and governments.

The STS of HRM4.0 for SCM is summarized in Figure 19. To manage the three-competency model (technical, social and personal/human), designed based on the results of the

systematic literature review, we present an STS framework. The association demonstrates that the necessary challenges of the digitization process and the smart industry cross the borders of HRM tasks, enabling it to connect a strategy of education with technology, forcing a more integrated STS by prioritizing technical (technological) issues over human aspects. We understand that human relations with technology will be recursive: humans create new business and organizational models to manage technology, and organizations provide infrastructure to adapt other humans to technology.

5. Final remarks

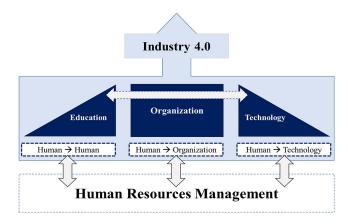
The analyzed articles point to the development context of Industry 4.0, highlighting how technology and knowledge are revolutionizing the operation of organizations. It is clear that this Fourth Industrial Revolution presents risks, opportunities and challenges. Risks are related to eventual job losses and the extension of the gap between developed and emerging economies. The opportunities can be summarized as a more efficient production system, combining low costs with customized products and services. When it comes to challenges, organizations are in a position to utilize intraorganizational processes to move toward HRM 4.0. This shift leads the traditional approach of hiring, selecting, assessing and rewarding to a new business model that has its basis in collaborative learning and competency development, leading to paths toward changes in education systems.

From this perspective, organizations are responsible for moving themselves into a socio-cyber-technical perspective and providing creative solutions to the unfolding human–machine interface. Figure 20 summarizes the theoretical contributions of this research corpus.

5.1. Key topics for a research agenda on Industry 4.0, HRM and SCM

In this context, the articles also show the importance of HRM for the development of Industry 4.0. Industry 4.0 is supported by advances in production and technology. However, the "glue" of the system is HRM. This implies changes in the way people relate to each other (human to human), the way they relate to the new business model and the way they relate to the innovations and technologies emerging in this new

Figure 20 A theoretical framework of actual knowledge corpus



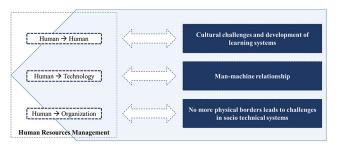
manufacturing smart industry (human to organization and human to technology) (Figure 21).

As a result of the systematic review conducted in this study, a framework with an agenda for future research is shown in Figure 22.

We can affirm that the literature is in the transition process from the early studies of German academia to the development of new impacts worldwide. Industry 4.0 is the central theme of the analyzed literature corpus, being accomplished through the development of employment, qualifications, skills and learning frameworks.

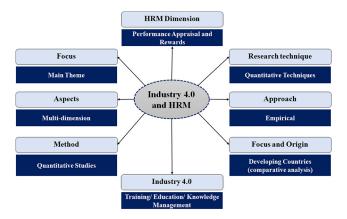
The results reveal that the existing papers are mostly conceptual, and quantitative methods are still lacking for

empirical applications. Developed countries, and especially the Central European region, figure as the center of the research production, while Latin America and Asia do not appear in any paper on the list. Empirical research has growth potential because Industry 4.0 is an emergent and relevant theme, seeking to develop insights through empirical research to face challenging problems.

The majority of the papers analyzed highlight changes in the way of working. There are also opportunities for studies that analyze other HRM dimensions, as the focus has been on training and development, leadership and teamwork and communication. It will be necessary to study new selection and recruitment models, as well as performance and new competencies.

Clustering has shown four main themes: labor changes, work conditions, environment and new skills demanded. Also, the labor market appears to be undergoing an unstable shift toward high-level context. The third theme relates to the technical interface of humans and machines, and finally, the fourth understands German industry as a starting point for global industrial improvements.

There is a great opportunity to discuss new demands on qualifications and education, to create a broader and better-structured knowledge of the basic concepts related to this new industrial revolution. Research into new jobs and new skill requirements will be necessary, and the role of universities and education from this perspective must be discussed.

Research focusing on how the labor market will be affected by the implementation of partnerships with collaborative robots is also on the agenda for future studies, as well as discussion about technological changes resulting in inequality and a possible expansion of precarious employment.

There is also an opportunity for studying the differences between countries, as the level of automation of each nation naturally adapts a faster performance in the organizational transformations towards Industry 4.0. Also, the social and technological impacts of this industrial revolution are felt differently in each nation, and this should present a rich research topic.

5.2 Potential implications for the SCM community

While the relationships among Industry 4.0, human-related aspects and SCM remain a scarcely studied topic, we believe

that the development of this theme will affect the SCM community and practitioners. Selected implications are:

- Industry 4.0 will require an adapted and well-equipped HRM. It is important that SCM managers and departments work closely with HR departments to understand the main skills, knowledge gaps and training necessities to keep the company competitive;
- global supply chains, spread across different nations, will need to be well managed and will need to align and coordinate efforts in terms of the adoption of Industry 4.0 and HRM initiatives that will support change management;
- SCM managers will need strong support from supply chain associations to further develop their understanding on the implications of Industry 4.0; and
- focal companies in a supply chain will most likely lead the
 adoption of Industry 4.0 technologies across the chain,
 and these focal companies will, therefore, need to carefully
 understand the impacts of new technologies on human
 resources-related topics, to maintain the competitiveness
 of their supply chains.
